LANDING AUTHORIZATION REQUESTS MUST BE SUBMITTED 48 HOURS BEFORE THE SCHEDULED FLIGHT DATE, BY EMAIL TO SURVOL(A)CCAA.AERO WITH COPY TO SERGES.NTAMACK(A)DIPLOCAM.NET AND BELINGALAURENT(A)YAHOO.FR. ALL FLIGHTS BRINGING PASSENGERS TO CAMEROON MUST LAND IN YAOUNDE AND ALL PASSENGERS DISEMBARKING IN YAOUNDE WILL BE QUARANTINED FOR 14 DAYS UNDER THE DIRECTIVES OF THE HEALTH AUTHORITIES.</p>

Equitorial Guinea	DUE TO RISK OF CORONA VIRUS, EQUATORIAL GUINEA AIRPORTS WILL BE CLOSED FOR INTERNATIONAL PASSENGERS COMMERCIAL FLIGHTS UNTIL FURTHER NOTICE
Gabon	COMMERCIAL PASSENGER, DOMESTIC AND FOREIGN FLIGHTS ARE PROHIBITED. Ghana	DUE TO COVID-19 PANDEMIC. ALL TRAVELS TO GHANA IS STRONGLY DISCOURAGED. ALL DIVERTED FLIGHTS TO ACCRA ARE NOT PERMITTED TO DISEMBARK PASSENGERS DUE TO THE GLOBAL COVID-19 PANDEMIC.

Mali	ALL COMMERCIALS TRAFFICS FROM COUNTRIES AFFECTED BY PANDEMIC "CORONA VIRUS" ARE SUSPENDED EXCEPTED CARGO FLIGHTS.
Mauritania	ALL AIRPORTS IN MAURITANIA ARE CLOSED TO COMMERCIAL TRAFFIC (ARRIVAL, DEPARTURE)
